

# Lilliput Neighbourhood Forum and Area Designation Consultation



Neighbourhood Forums work with local communities to prepare Neighbourhood Plans for their area and forum designations last for five years.

On 13 May 2025, a proposed new neighbourhood planning group applied to BCP Council to be designated as a neighbourhood forum, to operate as a qualifying body for the purposes of preparing a Neighbourhood Plan, in accordance with s61F Town and Country Planning Act 1990 and s8 Neighbourhood Planning (General) Regulations 2012.

We are asking for views and comments from residents and other interested parties on the proposed forum's application for qualifying body status and their neighbourhood area boundary. Your views should consider whether this forum should be designated for the purposes of preparing a neighbourhood plan for the proposed neighbourhood area.
